### **Monitoring Legislation That Impacts Business** • Visit Florida SB778 by Senator Hooper

Now that the Legislative Session has begun in Tallahassee, the Daytona Regional Chamber will be focused on supporting or opposing numerous bills that may impact our greater business community as highlighted below:

Daytona Regional

• With a FY 2020-21 budget at \$92.4 billion and an expected \$2 billion shortfall for the year were watching because coming approximately \$60 billion of this amount is recurring funds which will be allocated to state agencies and departments leaving \$32 billion for the legislature to consider. Meanwhile, the Governor's office is working with the legislature's Office of Economic & Demographic Research to prepare the budget. The Governor expects budget resources to change in the next few months and is proposing a \$96.6 billion budget.

• Vacation Rental Units - S 522 by Sen Diaz preempts local authority to regulate short-term rentals thereby shifting regulation by cities/counties to the State's Division of Hotels and Restaurants now under the Dept. of Business & Professional Regulation.

allows the Florida Tourism Industry Marketing Corporation to carry forward unexpended state appropriations into succeeding fiscal years. It also removes the scheduled repeal of the Division of Tourism Marketing within Enterprise Florida (House version is HB675 by Rep. Plasencia)

The Daytona Regional Chamber supports SB778 and HB675.

• Sales and Use Tax SB50 by Senator Gruters defines "retail sale" to include sales facilitated through a marketplace. It would require more remote sellers and marketplace providers to collect and remit Florida's sales tax (House version HB15 by Rep. Clemens).

The Daytona Regional Chamber supports SB50 and HB15.

• COVID-19-Civil Liability for Damages SB72 by Senator Brandes sets requirements for a civil action based on a COVID-19-related claim provided that a business is following health department guidelines. It also requires a higher level of proof from the plaintiff (House version CS/HB7 by Rep. McClure).

The Daytona Regional Chamber supports SB72 and HB7.



· COVID-19-Claims Against Health Care Providers SB74 Senator Brandes provides initial procedures for civil actions based on COVID-19-related claims and stipulates the standard of proof required at trial for such claims. It also stipulates immunity from liability for COVID-19-related claims under certain circumstances (House version HB7005 by Health-Human Services Committee).

The Daytona Regional Chamber supports SB74 and HB7005.

### **Daytona Beach City Manager Interviews Scheduled**



Since the announcement of long-time City Manager of Daytona Beach Jim Chisholm's retirement, the Daytona Beach City Commission has

narrowed down the list of potential candidates for its City Manager to five finalists.

The critical nature of this decision will influence the future of this city. Therefore, the Daytona Regional Chamber has been working to

include business representation in the process and will be present at the Candidate Forum to be held on Saturday, March 20 at 9:00 a.m. In addition to meeting the candidates and hearing of their vision for Daytona Beach, the Daytona Regional Chamber will present a list of questions to ascertain the candidates experience and knowledge of business and quality of life issues impacting our region.

The candidate forum will be held at the city's Midtown Cultural & Educational Center located at 925 George W. Engram Blvd. The City does ask that residents and businesses interested in attending to please register in advance so the venue can be properly setup for social distancing. For those indivdiduals unable to attend in person that morning who would still like to observe, plans are being made for the forum to be broadcast on codb.us/DBTV and Spectrum Channel 490.

months of careful planning with the members of our business community. Governmental officials and residents we have developed the safest plan possible to hold the event this year.


Many businesses have already endured significant operational changes needed over the past year to keep their customers and visitors safe while frequenting their business. Many have followed their industries best practices as well as CDC specific guidelines to ensure a safe operation.

Additionally, this year we have worked closely with our Bike Week participants incorporating specific safety site plans into each and every business submission to help with extending those important CDC protocols into their outside operations. On Main Street specifically the participants in the Master Plan coordinated by the Bike Week Festival Task Force for the City of Daytona Beach also voluntarily agreed to limit interior capacities to 60% to help with social distancing. Main Street itself also had an overlayed Safety Plan which includes Motorcycles Only for the whole ten days, reduced curbside parking creating more sidewalk space for social distancing and added parking at the Ocean Center for motorcycles to help with the traffic and pedestrian flow.

The County of Volusia has also offered their Wash Up, Back Up Mask up program with special messaging for riders entering our community for the event. Original posters are also available for posting as well as signage within the Back in Business campaign. Our advertising from HAAA also included safety messaging to advance the efforts.

## Equity Diversity & Inclusion Council Accepting Applications



In an effort to reach out to minority owned businesses, a scholarship fund, Daytona Business United, has been established by the Chamber's Equity Diversity & Inclusion (EDI) Council. Founding partner, AT & T has stepped up to kick off the funding and provide 8 scholarships to the program. Additional funding will be provided by private-sector partners.

As presented by EDI Council Chairperson, Carmen Ruiz, FASTSIGNS of Daytona Beach, the program is intended to assist minority-owned businesses by providing mentorship, business education and support over a two-year period. Partnering with the Small Business Development Center (SBDC), a customized **program** will be developed and supported by the EDI Council. Ruiz noted that "program participants are required to attend a program orientation, Daytona Business United quarterly meeting, connect with a mentor and fulfill the requirements of the agreed and custom developed strategic plan from the SBDC. This program will require a two- year commitment and an application fee of \$225." All other expenses are paid for by the scholarship fund.

We are currently accepting applications for the program. A simple one-page application can be found on the Chamber's website, daytonachamber.com, in the membership area under Equity Diversity & Inclusion.

We encourage our members to reach out to minority owned businesses and encourage their participation in this program.
