# **Daytona Regional Chamber Calls for Business Liability Protection**

The Daytona Regional Chamber recently expressed its support of legislation to discourage frivolous lawsuits against businesses operating during the COVID-19 pandemic. Many businesses are struggling to either maintain or return to operations and Governor DeSantis has worked to balance pandemic safety concerns with the survival of Florida's economy. Across the country, the number of lawsuits related to COVID-19 is growing and business owners are barely managing to persevere through the pandemic recession while battling crippling litigation.

The Florida Legislature is considering measures that would provide tort immunity and liability protections for businesses from claims of COVID-19 exposure. These liability protection measures are also being considered as a part of the next stimulus package being negotiated in Washington, D.C. In a recent Tallahassee Speaker Series event hosted by the Daytona Regional Chamber, Florida

Representative Tom Leek commented, "Liability cases can become complex, drawn out and expensive – it is not losing the lawsuit that

gets you, it's the fact of the lawsuit that gets you."

State CFO Jimmy Patronis said, "As a former small business owner myself, I understand the real liability challenges facing our businesses as they work to reopen safely in the face of COVID-19. ## Chairman's Perspective

Occasionally, in my remote-working pandemic existence, I have succumbed to the temptation to watch television news for updates on the active hurricane season, the dynamic political arena or the hope of encouraging news about college football this

fall. The only thing worse than the dire reports of natural disasters threatening our coastal communities, hysterical stories of political intrigue and the touch-and-go status of a 2020 college football season is the ceaseless barrage of ads by plaintiffs' lawyers. It is a startling reminder of why the American Tort Reform Association (ATRA) has consistently listed the entire state of Florida as a "judicial hellhole." In fact, Florida had the distinction of being listed by ATRA as the Number 1 "judicial hellhole" in the United States. The ads and billboards that overwhelm our consciousness in Florida are a testament to the fertile ground for tort litigation and the strength of the plaintiffs' bar. Now, with

COVID-19, the plaintiffs' bar is not letting a good crisis go to waste. They have sprung into action seeking businesses to assail. Restaurants, nursing homes, hotels, hospitals, schools and just about every other segment of our economy are under attack even as they struggle for survival in the pandemic-induced economic recession. Florida businesses desperately need tort liability protections from our legislature, but timing and substance of this hopeful legislation is a fraught issue.

The 2020 Florida legislative session was in its final weeks when the pandemic descended upon the United States. Unfortunately, it was too late to provide needed tort immunity or liability protections for businesses being ravaged by shutdown orders and lawsuits arising out of an unprecedented global phenomenon. The upcoming 2021 Florida legislative session is scheduled to commence on Tuesday, March 2, 2021. That is approximately five months of additional time for businesses to continue to endure the COVID-19 pandemic, the uncertain

# Florida Enters Phase 3 of Reopening

On Friday, September 25, Florida Governor Ron DeSantis issued an executive order ushering the state into Phase 3 of reopening amidst the COVID-19 pandemic.

Among the highlights of Phase 3:

- Restaurants may reopen at a minimum capacity of 50% if local regulations prevent them from resuming full capacity.
- While mask rules and regulations may still be implemented at the local level, the executive order suspends the collection of fines and penalties upon individuals.

FLORIDA AMENDMENT 1: Citizen Requirement for Voting	Stipulates that only US citizens are qualified electors in Florida. Florida's current constitution says every citizen can vote. This would stipulate only citizens can vote.	(3)
FLORIDA AMENDMENT 2: \$15 Minimum Wage	Raises minimum wage to \$10.00 per hour effective September 30, 2021. Each September 30 thereafter, minimum wage increases \$1.00 per hour until the minimum wage reaches \$15.00 per hour September 30, 2026. Afterwards, future minimum wage increases would then be adjusted annually for inflation starting September 30, 2027.	9
FLORIDA AMENDMENT 3: Top-Two Open Primaries	Would allow for open primaries for state offices. It would replace closed primaries with a 'top two' primary system whereby all candidates would be placed on one ballot regardless of political affiliation. Top two candidates with most votes would advance to general election.	
FLORIDA AMENDMENT 4: Require Constitutional Amendments to be Passed Twice	Currently in Florida, an amendment is approved at one general election (with a 60% majority) to become part of the constitution. Amendment 4 would require that any future amendments be approved by two consecutive general election ballots (by a 60% majority) to be ratified.	
FLORIDA AMENDMENT 5: Extend "Save Our Homes" Portability Period	Would increase the period during which a person may transfer "Save Our Homes" benefits (assessed at less than just value) to a new homestead property from two years to three years.	
FLORIDA AMENDMENT 6: Homestead Property Tax Discount for Spouses of Deceased Veterans	Would allow a homestead property tax discount to be transferred to the surviving spouse of a deceased veteran.	
Volusia County CHARTER AMENDMENT: Volusia ECHO: Environmental, Cultural, Historic and Outdoor Recreation Projects to Enhance Our Quality of Life	Would allow Volusia County to continue to fund environmental, cultural, historic and outdoor recreation projects for public use, including issuing bonds not exceeding \$40 million, payable from continuation of an existing ad valorem tax not exceeding 1/5 mill levied for 20 years.	
Volusia County Charter Amendment: Volusia Forever	Would allow Volusia County to continue to fund the acquisition and improvement of environmentally sensitive, water resource protection, and outdoor recreation lands for conservation and resource-based recreation, including issuing bonds not exceeding \$60 million, payable from continuation of an existing ad valorem tax not exceeding 1/5 mill levied for 20 years.

outcome of local and national elections, the volatile economic environment, and the highly active litigation climate. Even with the very best of legislative results, it may be too little, too late for businesses currently being sued and hanging on by their fingernails. Retroactive applicability of tort immunity or liability protections to actions already pending or filed prior to effective legislation is highly unlikely.

Substantively, tort immunity and liability protection for businesses may take two forms: (1) an absolute bar of any common law tort cause of action for COVID-19 exposure; or (2) a cause of action with a heightened burden of proof (clear and convincing evidence instead of a preponderance) or limitation to certain types of defendant conduct (willful and wanton conduct instead of simple negligence). Both options have great promise and a steep political hill to climb. Proving causation or, in other words, where a person might have "caught the bug" of COVID-19 is an almost insurmountable burden of proof when dealing with a virus that is aerosolized and highly transmissible. Also, the liability protections might be great, but businesses will continue to incur defense fees and costs in fighting to assert the protections. Thus, litigation will continue to be expensive for businesses even with statutory defenses and protections.

Nevertheless, some protection from our state legislature is better than nothing at all regardless of the timing, the effective date or the substance of the law. Your Daytona Regional Chamber of Commerce steadfastly aligns with the U.S. Chamber and the Florida Chamber in supporting and legislature encouraging delegation to congressional enact legislation to protect businesses from COVID-19 lawsuits. I understand that plaintiffs' law firms are businesses too. They have payrolls to meet, advertising budgets to fulfill and ad spaces to purchase. Profiting off the anguish of other local businesses in a global pandemic should not be a business plan suffered or allowed, even in a "judicial hellhole."
