Following a reception at the outset of the event, attendees will enjoy dinner and a program featuring the presentation of the Daytona Regional Chamber's most prestigious business awards, the J. Hyatt Brown Enterprise Award and the Glenn Ritchey Leadership Award, as well as remarks from 2023 Chairperson of the Board, Nellie Lupoli of **ICI Homes**.

Nebraska Senator and Incoming President of the University of Florida Dr. Ben Sasse will be the featured presentation for the Daytona Regional Chamber's signature business event. Dr. Sasse, who will be interviewed in a "fireside chat" format by our illustrious Lieutenant Governor, Jeanette Nunez, will share with us some insight into world affairs and the impact that the University of Florida plans to

have on the entire sunshine state.

The son of a coach and a graduate of Fremont High in Fremont, NE, he was recruited to wrestle at Harvard and subsequently

Sasse Harvard and subsequently earned a PhD in American history at Yale. An occasional professor, Ben has spent most of his work life helping companies and institutions through technological and leadership disruptions. He's worked with the Boston Consulting Group and McKinsey and Company, as well as private equity firms and not-for-profit organizations, to tackle failing strategies across dozens of sectors and nations.

In the U.S. Senate, Dr. Sasse serves as a member of the intelligence, judiciary,

finance, and budget committees. He was first elected to the Senate in 2014 and re-elected in 2020 winning all 93 counties in Nebraska on both occasions.

Jeanette M. Nuñez was born and raised in Miami, Florida. She was elected as Florida's First Hispanic Female Lieutenant Governor of Florida in 2018. She previously served as a State Representative of the Florida House of Representatives from 2010 to 2018 and was named Speaker Pro Tempore from 2016 to 2018.

The Daytona Regional Chamber of Commerce's Board of Directors approved its 2023 legislative priorities at its final meeting in December. With the legislative session beginning in March and the Volusia County Delegation meeting on January 9th, the priorities will set the direction of the Chamber's advocacy efforts during the session(s).

The Daytona Regional Chamber's 2023 priorities started with an open membership survey asking our members to outline their essential issues affecting our community. After conducting the survey, the Daytona Regional Chamber's Cornerstone Committee reviewed the top priorities and presented them for board approval.

The Daytona Regional Chamber's Priorities will be the framework during the 2023 Legislative Session. The priorities will also direct our annual scorecard and will be delivered to our Volusia County Delegation during our annual Volusia Days trip to Tallahassee in March of 2023. 2023 Legislative Priorities include:

Affordable Housing

The Daytona Regional Chamber of Commerce advocates for legislation supporting the continued growth of Affordable Housing across our region and the State of Florida.

Disaster Recovery

The Daytona Regional Chamber of Commerce supports funding Disaster Relief and Recovery Bills due to Hurricane Ian and Nicole's impact on our community and State.

The Daytona Regional Chamber of Commerce supports funding and regulatory reform to strengthen and modernize infrastructure to relieve flooding and coastal deterioration.

Insurance

The Daytona Regional Chamber of Commerce supports a competitive and stable insurance market and a reduction of size and exposure to Citizens' Insurance.

Lawsuits Abuse/Tort Reform

The Daytona Regional Chamber of Commerce supports comprehensive tort reform, discouraging frivolous lawsuits in Florida.

Workforce Availability

The Daytona Regional Chamber of Commerce supports efforts to ensure that our community continues to have a skilled workforce.

Volusia Delegation Meeting

The Daytona Regional Chamber will be delivering its 2023 Legislative Priorities on Monday, January 9 during a public meeting. The Volusia County Legislative Delegation will hear testimony from the public and other stakeholders on matters affecting our local community and the state of Florida. The public hearing will take place from 9:00 a.m. until 1:00 p.m. at DeLand City Hall, 120 S. Florida Ave., DeLand, FL, 32720.

Special Session

During a special session in December 2022, state legislators passed three bills targeting Property Insurance, Disaster Relief, and Toll Relief. One bill establishes the Florida Option Reinsurance Assistance (FORA). Reinsurance rates are expected to increase at least 50%. To cover the increased cost, insurance companies pass on those expenses to policyholders in the form of premium increases. The Legislature is hopeful that lower reinsurance rates offered through the program will decrease the need for insurance companies to increase premiums.
