Nomination Guidelines

The Daytona Regional Chamber of Commerce is now accepting nominations for the 2026 Small Business of the Year Award. The objective of this award is to recognize and honor businesses who have demonstrated exemplary "Best Practices."

Nominated businesses must complete the Small Business of the Year Award application to be considered. A member of the Daytona Regional Chamber of Commerce Awards Committee will contact the nominee, inform them of their nomination, and ask them to complete the application.

Award Eligibility Criteria

- Any for-profit business headquartered in Volusia County with 1-50 employees
- The applicant must be the owner, partner, or major shareholder of the business and active in its day-to-day operations
- The business must be financially stable and in operation for a minimum of three years
- Businesses must be a current Member in good standing of the Daytona Regional Chamber at time nominees are announced
- Past Small Business of the Year Award recipients may not re-apply
